## MINIATURE AND TOY AUSTRALIAN SHEPHERDS N.S.D. REGISTRATION FIRST SHOTS, AND WORMED

### CONTRACT OF SALE FOR DOGS

Buyer is responsible for paying full shipping cost, including appropriate sized crate.

The Dog is a purebred Miniature Australian Shepherd sired by \_\_\_\_\_; Dam is \_\_\_\_\_.

This Dog can be registered with the National Stock Dog Registry.

The buyer agrees to have the Dog examined by a licensed veterinarian within three (3) ...days of receipt of the puppy, excluding weekends. IF the Dog is determined to be in poor health, as evidenced by a veterinarian's written statement, the Buyer can elect to keep the Dog, assuming all costs for its care, or may return the Dog for a full refund upon the Breeder's receipt of the veterinarian's statement regarding the dog's health.

Breeder guarantees this Dog free of hip or eye defects of a genetic origin for a period of two years. In the event hip or eye defects occur, Buyer will provide written certification from Orthopedic Foundation for Animals (OFA) or the Canine Eye Registration Foundation (CERF), respectively, as evidence of the defect. The guarantee consists of replacement of the Dog with a dog of equal quality, selected by the breeder, when breeder has next available litter of puppies.

The Dog is being sold as Pet Quality which is defined as a puppy that is not guaranteed to show in conformation classes and is not for breeding purposes. This puppy must be spay or neutered by seven (7) months of age.

This Sales Contract is non-transferable. Should buyer relinquish ownership of said Dog, this Sales Contract shall be deemed null and void.

In the event of dispute the state of Oregon will have jurisdiction over the matter and prevailing party is entitled to their (all/full) legal fees and expenses incurred.

Although there are no plans at present to stop breeding Miniature Australian Shepherds, this Sales Contract and above guarantees are valid only so long as Breeder is breeding said dogs.
